



## ELECTRONIC SIGNATURE VERBIAGE

### BRAND PARTNER AGREEMENT

#### Section I: Acceptance of the Agreement

Welcome to the Veribella Inc. business. Please read the Veribella [Brand Partner Agreement](#) and the Veribella [Policies and Procedures](#) carefully, collectively referred to as the “Brand Partner Agreement.”

#### Section II: Business Kit

At the time of your enrollment as a Brand Partner, you agree to purchase a Business Kit. This Kit is non-commissionable. Should you want to cancel your business and request a refund on this Kit, you must do so within three (3) days from the date of the transaction. A refund no longer exists upon the expiration of this three-day period.

#### Section III: E-Sign Notice- Consent to Electronic Record

E-Sign, the *Electronic Signatures in Global and National Commerce Act* (15 U.S.D. 7001, *et seq.*), requires that you consent to entering into an electronic agreement with Veribella before a Brand Partner Agreement can be executed.

#### Please read the following information carefully:

- If you enter into an online Brand Partner Agreement with Veribella, you will not be required to submit a paper application. An electronic record will evidence the entire agreement between you and Veribella. However, you must consent to the use of an electronic record and must read the Veribella Terms of Use, the Veribella Policies and Procedures and the Veribella Compensation Plan, and electronically acknowledge below that you have read these documents.
- To access these documents and submit your online Brand Partner Application, you will need a personal computer or Mac with Internet access and operational Internet browser software.

By clicking on “I agree” below, you consent to the use of electronic records evidencing your agreement to the Veribella Terms of Use, Policies and Procedures and the Compensation Plan of the Brand Partner Agreement. If you click on the “I Decline” box, the enrollment process will be terminated, and you will be returned to the Veribella Home page.
